Prescription drug options

We offer prescription drug coverage at a variety of co-payment levels, on either a pay direct or reimbursement basis. With pay direct your employees pay only their portion of the prescription cost and the remainder is billed directly to Alberta Blue Cross. With reimbursement, employees pay the full cost of the prescription up front and then submit a claim form with their receipt to Alberta Blue Cross for payment.

We also offer many cost management features such as specific plan benefit maximums and deductibles.

Coordination of Benefits

Alberta Blue Cross offers Coordination of Benefits (COB). This is a process where an individual, couple or family with more than one benefit plan combine their benefits coverage. This allows an individual, couple or family to have coverage up to 100 per cent of the dollar value eligible for prescription drug benefits. COB is a standard practice among benefit carriers in Canada to allow people with more than one plan to maximize their benefits.

Our real-time adjudication system, PRIDE RT, allows pharmacists to submit pay direct claims electronically. Adjudication of your claim takes only seconds, the best response time in the industry. Plus, pharmacists can access information on patient coverage, benefit eligibility, applicable benefit caps, benefit restriction, deductibles or maximums to allow onthe-spot informed decisions.

PRIDE RT also includes Drug-to-Drug Interaction Screening, which automatically screens all direct-bill prescription drug claims for possible interactions with previously dispensed prescriptions. This tool can assist the pharmacist, protecting you and your employees against potentially dangerous drug combinations.
