LIFTERS AND ACCESSORIES

Eligibility: The client must have **funding in place for overhead track**, including installation (client responsibility), and this must be indicated on the authorization submission. Clinical rationale for heavy duty models includes the client's weight. A quantity and frequency review is required if replacing lifters within four years.

Authorizers: Inquire with the Recycle Vendor first to search the recycle inventory. Authorization type will be for either “recycle” or “new” equipment. New equipment can only be ordered after the recycle inventory has been searched and authorizer has received a written confirmation that there is no suitable equipment available.

When uploading authorizations, please **notify the vendor when the authorization is submitted and approved as the vendor is no longer notified automatically**. Authorizations are not vendor specific.

Recycle patient lifters are provided through the AADL recycle program and must be returned to an AADL vendor when the client no longer needs it.

Only one type of lifter will be provided – either an overhead track lifter or portable floor lifter. Manufacturer and model must be indicated.

Slings are considered benchmark benefits and are not recycled by AADL.

Minimum Standards for Lifters: Minimum three-year warranty on lifters, one year on battery, one year on hand pendant and one year on charger. Must have safety mechanisms – emergency lowering & stop, slack strap switch and over-speed governor.

PORTABLE FLOOR LIFTERS

Eligibility: Indicate client's weight on all authorizations to support choice of product. Quantity and frequency reviews are required if replacing lifters within four years. One type of lifter will be provided – either an overhead track lifter or portable floor lifter. Manufacturer and model must be indicated on authorization.

Authorizers: Inquire with the Recycle Vendor first to search the recycle inventory. Authorization type will be for either “recycle” or “new” equipment. New equipment can only be ordered after the recycle inventory has been searched and authorizer has received a written confirmation that there is no suitable equipment available.

When uploading authorizations, please **notify the vendor when the authorization is submitted and approved as the vendor is no longer notified automatically.** Authorizations are not vendor specific.

**SLINGS
(Benchmark/non-recycle)**

Slings are considered benchmark benefits and are not recycled by AADL. Slings are only provided for AADL-approved manufacturers for patient lifters, including floor and overhead.

Eligibility: Must indicate client's weight on all authorizations to support choice of product. Slings must be compatible with all patient lifters in this approved product list.

Minimum Standards for Slings: Minimum two-year warranty on slings.

Costs: AADL prices are based on MSRP minus vendor discount quoted on matching lifter. Pricing is based on the maximum price funded for a sling and is not intended as the price for all types of slings under that manufacturer. Consult with the vendor for individual prices as these will vary according to type.

Approved Manufacturers: Argo Huntleigh, Joerns, Humancare, Molift, Protekt, Goldman, Drive, Silvalea, Handicare/Prism, Lifemed, Savaria for floor and ceiling lifts only. Manufacturer and model of the client's lifter must be indicated on the authorization.
