#### **Claim payments**

To avoid delays in receiving payment, we encourage you to ensure that you are signed up for direct deposit of funds. The application for direct deposit of funds for dental providers can be found on the Alberta Blue Cross<sup>®</sup> website at <u>https://www.ab.bluecross.ca/pdfs/55233.pdf</u>.

#### **Dental provider website**

Once you are signed up for direct deposit, we ask that you register for access to the dental provider website. Visit **ab.bluecross.ca/pdfs/how-to-register-for-the-dentalprovider-website.pdf** for information on how to register for the website.

The website will allow you to access:

- Claim payment reports
- Predeterminations and orthodontic treatment plan evaluation reports
- · Individual patient statement reports
- Member coverage look-up

The provider website also allows you to submit exceptions and vouchers for Alberta Health dental plans and contains valuable information for dental providers, including Benefact newsletters, claiming tips, community news and other updates from Alberta Blue Cross.

#### **Claim and predetermination submission**

To avoid delays in claim processing, please submit all eligible claims and predeterminations electronically.

Alberta Blue Cross supports the electronic submission of claims, including claims with coordination of benefits, through CDAnet, DACnet and CDHAnet. Please ensure that your software is updated to the latest version to increase the likelihood of successful electronic claim submission.

All dental services can be submitted electronically, except for:

- Orthodontic treatment plans (OTPs)
- Accidental dental claims
- Certain COB claims

If a claim or predetermination cannot be submitted electronically, they may be delivered in person or through courier to the claims drop box at one of our five locations – Edmonton, Calgary, Grande Prairie, Lethbridge, and Red Deer.
