

Compound PINs reference guide

To enhance the efficiency of claims adjudication, all compounds submitted to Alberta Blue Cross should be dispensed using one of the compound PINs listed in the following tables. The PINs assist in the categorization of compound products based on therapeutic drug classification and in the identification of compound products prepared and dispensed by a community pharmacy.

Compound PINs to be used when submitting claims for **compounds prepared and dispensed by a licensed community pharmacy**:
