## COMPLIANCE VERIFICATION BENEFACT UPDATE

At Alberta Blue Cross, we are committed to safeguarding the value and sustainability of the benefit plans and programs we are entrusted to administer. To ensure plan sponsor payment of eligible claims is done appropriately, we employ strategies to protect the integrity of our customers' benefit plans.

## Claims submissions for compounds purchased from a compounding and repackaging pharmacy.

We would like to remind all pharmacy providers to be aware of the following provision within the Alberta Blue Cross Pharmaceutical Services Provider Agreement:

Subsection 2.4 (a) (x) of Appendix A:

(x) "Purchased Compound Price" – means the Provider's actual price paid for a Purchased Compound as evidenced by an invoice and a receipt prepared by the Compounding and Repackaging Pharmacy and given to the Provider.

A completion of a recent Compliance Verification Review on claims submitted by a pharmacy provider determined that claims for purchased compounds were submitted at a unit price which did not accurately reflect the actual price paid to the compounding and repackaging pharmacy for products received. The pharmacy's drug file had a unit price which was incorrect and was not updated as compounds were purchased from the compounding and repackaging pharmacy.

This review resulted in a recovery of greater than \$49,000. As part of our processes we have returned the monies directly back to the plan sponsor in fulfillment of our obligation to ensure the sustainability of their benefit plans.
