

COVID oral antiviral dispensing—follow-up Oral antiviral access point selection

Alberta Health has completed the first round of pharmacy selection for dispensing COVID oral antiviral drugs. Health Canada approved the first of these drugs, nirmatrelvir/ritonavir [Paxlovid™ (Pfizer)], on January 17, 2022. Paxlovid™ will be available to eligible Albertans with a positive COVID-19 PCR test starting on January 31.

With the initial expression of interest, more than 900 sites responded from across the province. Given the very limited initial supply, approximately 135 pharmacies have been selected to provide access across the province. Selected pharmacy sites were notified with further information on next steps.

As the supply of COVID oral antivirals increases, opportunities to add more pharmacies will become available. Alberta Health will provide further communications to pharmacies as information on supply evolves.

Criteria used for pharmacy selection

Sites were selected from submissions based on the following criteria from the EOI:

- Open seven days a week where possible (or have pharmacist publicly on call on days the pharmacy is closed).
- Offer two or more no-contact dispensing options such as
 - delivery when required;
 - curbside pick-up and/or drive thru; and/or
 - mail-order where appropriately licensed by the Alberta College of Pharmacy.
- Committed to strict inventory management processes to ensure product is always on hand and ready to be dispensed.
- Committed to daily inventory and utilization reporting.

In addition, where more than one pharmacy expressed interest in a given local geographic area, additional criteria were applied, including

- regular use of AVI and AVBS systems demonstrating inventory control commitment,
- location within the local geographic area, and
- hours of operation.
