Due to the shortages of specialized infant formulas in Canada, Health Canada has allowed the importation of Nestle Health's UK-labelled Alfamino Infant Formula Powder and US-labelled Gerber Good Start Extensive HA Infant Formula Powder. **These products are to be kept behind the counter of the pharmacy.**
