COVID-19 Vaccine PIN Eligibility Update

As of Monday, June 12, 2023, eligible PINs for COVID-19 vaccines are being limited to reflect the vaccines currently available in pharmacies.

The following SpikeVax (Moderna) COVID-19 vaccines are no longer available in Alberta as provincial inventory has expired.

- Spikevax (Moderna) bivalent COVID-19 vaccine for Albertans 18 years and older.
- Spikevax (Moderna) original (monovalent) COVID-19 vaccine for Albertans 6 years and older.

Please remove any Spikevax (Moderna) vaccine products from your fridge and ensure to reconcile the inventory in the Alberta Vaccine Inventory (AVI) system.

There continues to be a good supply of the Comirnaty (Pfizer-BioNTech) bivalent booster vaccine, so these changes will not impact access or availability of COVID-19 vaccines.

The Pfizer-BioNTech Original (Monovalent) and Comirnaty (Pfizer-BioNTech) bivalent COVID-19 vaccines are still available for eligible Albertans as primary series or bivalent booster doses.

The Comirnaty (Pfizer-BioNTech) and Spikevax (Moderna) products are both safe, effective and interchangeable.

Children under 12 years of age should be referred to Alberta Health Services (AHS). Albertans can book appointments with AHS by calling 811 or booking online through the Alberta Vaccine Booking System (AVBS) at **bookvaccine.alberta.ca**.

Quarterly update regarding the Authorized Adjustment

The Alberta government, the Alberta Pharmacists' Association and Alberta Blue Cross® continue working collaboratively to monitor pharmacy compensation expenditures and trends for drug benefit fees and pharmacy services. As previously communicated in Benefact 865, a provision exists to enable an Authorized Adjustment mechanism, through a consultative process, should expenditures trend towards exceeding established budget targets. With the completion of the fourth fiscal quarter (January 1 to March 31, 2023), expenditures remain within budget targets, and as a result, there was no need to initiate consultations on the Authorized Adjustment.
