Temporary benefits added to the ADBL

Due to the unavailability of Janumet XR 50 mg/1000 mg Extended-Release Tablet (DIN 02416794) manufactured by Merck Canada Inc., **Sandoz Sitagliptin-Metformin XR 50/1000 mg ER Tablet (DIN 02529114)** manufactured by Sandoz Canada Inc. will be considered a temporary benefit for the *Alberta Drug Benefit List (ADBL)*. This grouping was added to the Critical Supply Product List **August 27, 2023**.

As of **August 27, 2023**, all claims for Sandoz Sitagliptin-Metformin XR 50/1000 mg ER Tablet (DIN 02529114) will be adjudicated to the price published in the most recent *Alberta Blue Cross Drug Price List (ABCDPL)* until further notice.
