

## Alberta Health Services QuitCore program (Group number 23699, Section A)

Effective June 1, 2016, the Alberta Health Services QuitCore program—designed to assist Albertans in making a change in their tobacco use— will provide participants meeting eligibility criteria Nicotine Replacement Therapy (NRT) drug benefits at no charge.

QuitCore is a free group support program designed to assist adult Albertans in making a change in their tobacco use whether their goal is smoking cessation, to reduce their use as an interim step or they have recently quit and wish to maintain the change. While the majority of people who attend QuitCore are people who are currently smoking, it is also open to those who use smokeless tobacco. Group cessation programs are one of the most effective means of increasing an individual's chances of quitting tobacco use successfully.

QuitCore groups are offered in more than 20 communities around the province through partnership with AHS programs, primary care networks, family care clinics and specialty settings. This opportunity allowing participants to connect with the knowledge and expertise of community pharmacists through this new NRT support program is a valuable evolution of service. Pharmacists play a key role in helping Albertans towards a tobacco-free future.

### Program participation and benefit eligibility

Participants eligible to receive NRT will receive an enrolment confirmation letter from Alberta Blue Cross which will include a list of eligible NRT products and an Alberta Blue Cross ID card specific to the QuitCore program. Participants may present the letter at the pharmacy. **Pharmacists do not need to keep this letter on file.** Participants are required to present their Alberta Blue Cross QuitCore ID cards at the pharmacy and are able to receive 100 per cent coverage for eligible NRT products up to a maximum of \$500.00 within the seven month period following their enrolment in the QuitCore program.

### Claiming details for pharmacy providers

When billing claims for the eligible NRT products, Alberta Blue Cross requires that the claims be submitted electronically through the Alberta Blue Cross PRIDE-RT direct bill claim adjudication system with the following claim data elements:

- Carrier Code 11
- Group number for all transactions should be 23699, Section A
- Claims are to be submitted with the appropriate Natural Product Number (NPN) from the product list provided on the next page
- Drug Cost – based on the Manufacturer List Price (MLP) or the Base Price plus Allowable Upcharge #1, Allowable Upcharge #2, Dispensing Fee up to a maximum of \$12.30

The Program provides for direct bill claims submission only. Participants are not eligible to claim for reimbursement.

Supplementary documentation to support claims submission must be kept in the patient's file (or record of care).
