

## National Poison Prevention Week is March 19 to 25—help to protect children from medication poisoning

Consider a few key figures:

- In 2015, the Poison and Drug Information Service (PADIS) received more than 15,600 calls from individuals concerned that a child had been poisoned.
- In 2014, 1,750 children under the age of 10 visited emergency departments due to unintentional poisoning. Prescription medication was involved in seven out of 10 of these visits.

Improperly-stored medications are the leading cause of childhood poisoning in Alberta. As a pharmacy, you are well-equipped to provide valuable information on the safe storage of prescription and over-the-counter medications to parents and caregivers in your community during Poison Prevention Week.

### Check out the guidebook

The Injury Prevention Centre's guidebook was created to improve awareness of medication poisoning and increase prevention of medication-related poisonings in children. The information in this guidebook is geared towards parents, grandparents and caregivers. It includes engaging activities and provides readers with tools to better protect those in their care who may be vulnerable to medication-related poisoning.

## The key messages of poison prevention

- Store all medications so that they are tightly locked and out of sight.
- Take your medications in a place that is out of sight of children.
- Keep visitors' bags and coats out of reach.

Ran-Nabilone 0.25 mg Capsule (DIN 02358077), manufactured by Ranbaxy Pharmaceuticals Canada Inc, Teva-Nabilone 0.25 mg Capsule (DIN 02392925) manufactured by Teva Canada Limited and Cesamet 0.25 mg Capsule (DIN 02312263) manufactured by Valeant Canada LP were added as temporary benefits for the Alberta Drug Benefit List (ADBL).

Valeant Canada LP has advised Alberta Blue Cross that the shortages of Cesamet 0.5 mg Capsule (DIN 02256193) and Cesamet 1 mg Capsule (DIN 00548375) have been resolved.

As a result, Ran-Nabilone 0.25 mg Capsule (DIN 02358077), Teva-Nabilone 0.25 mg Capsule (DIN 02392925) and Cesamet 0.25 mg Capsule (DIN 02312263) will no longer be considered temporary benefits for the ADBL **after April 7, 2017**.

Due to the shortages of pms-Oxycodone 5 mg Tablet (DIN 02319977) manufactured by Pharmascience Inc. and Supeudol 5 mg Tablet (DIN 00789739) manufactured by Sandoz Canada Inc., Oxy-IR 5 mg Tablet (DIN 02231934) manufactured by Purdue Pharma was added as a temporary benefit for the Alberta Drug Benefit List (ADBL).

Pharmascience Inc. and Sandoz Canada Inc. have advised Alberta Blue Cross that the shortages of pms-Oxycodone 5 mg Tablet (DIN 02319977) and Supeudol 5 mg Tablet (DIN 00789739) have been resolved.

As a result, Oxy-IR 5 mg Tablet (DIN 02231934) will no longer be considered a temporary benefit for the ADBL **after April 7, 2017**.

# Product supply shortage addressed for *Alberta Drug Benefit List (ADBL)*

Alberta Blue Cross has been advised by Pharmascience Inc. that the shortage for of pms-Oxycodone 5 mg Tablet (DIN 02319977) has been resolved. Due to the long-term nature of this shortage, a transition period will be applied, and as a result, the LCA price policy will be reapplied to the following grouping effective **April 7, 2017**.
