

## Blood Glucose Test Strip Limit

Effective September 1, 2018, Alberta Blue Cross will apply a new quantity limit for Blood Glucose Test Strips (PIN 00999955) on select employer-sponsored group plans that provide coverage for diabetic supplies.

Please be aware that this limit is specific to Alberta Blue Cross employer-sponsored group plans only, and is different from any existing limits for this product under government-sponsored drug coverage or Individual Product plans. Government-sponsored drug coverage will not be impacted by these changes and any other existing limits will remain unchanged.

The Blood Glucose Test Strip limit for select employer-sponsored group plans will be based on the member's benefit year, as defined by the plan administrator. The quantity limit will reset annually at the beginning of each benefit year. Once the member has claimed the maximum quantity of blood glucose test strips for the benefit year, any additional claims within the same benefit year will reject with the CPhA code of **C5 - plan maximum exceeded**.
