

## Interim Order Issued by Health Canada for Epinephrine Shortage - Temporary Benefit added to the *Alberta Drug Benefit List (ADBL)*

On August 29, 2018, Health Canada issued an Interim Order to allow the import of Auvi-Q 0.15 mg Auto-Injector Syringe from the USA and has issued the product a temporary Product Identification Number (PIN 02480360).

The Interim Order was issued as an emergency measure and response to the unavailability of Epipen Junior (0.15 mg) Auto Injector Syringe (DIN 00509558) and Epipen (0.3 mg) Auto Injector Syringe (DIN 00509558). On August 29, 2018, Auvi-Q 0.30 mg Auto-Injector Syringe (DIN 02480379) was added as a temporary benefit.

Due to the unavailability of Epipen Junior (0.15 mg) Auto Injector Syringe (DIN 00509558), Auvi-Q 0.15 mg Auto-Injector Syringe (PIN 02480360) will be considered as a temporary benefit for the *Alberta Drug Benefit List (ADBL)*.

As of **August 29, 2018**, all claims for the above product will be adjudicated to the price of **\$180.0000 per auto-injector syringe**. McKesson has advised that stock is in transit to their Alberta McKesson warehouses.

Please note that although this product is sold as a package of two with an auto-injector and trainer device, Health Canada has indicated that single auto-injectors may be dispensed as necessary to conserve supply and that Patient Instructions for Use must be provided with each Auvi-Q Auto-Injector dispensed.

Alberta Blue Cross will continue to monitor the availability of the shorted products and potential alternatives, in addition to working with other provinces and territories, manufacturers and Health Canada to address this shortage and minimize the impact on Albertans.

This product is subject to the usual review process by the Expert Committee on Drug Evaluation and Therapeutics and must be approved by the Minister of Health for addition to the *ADBL* in order to be a formal benefit.

## Product supply shortages addressed for Alberta Drug Benefit List (ADBL)
