

Temporary increase to Assessment for the Administration of a Publicly Funded Vaccine fee

Recognizing the vital role Alberta pharmacists continue to play in preventive health care and the challenges community pharmacists face as they shift practice operations including workflow, staffing, and incorporation of additional PPE, Alberta Health has temporarily increased the fee for the Assessment for the Administration of a Publicly Funded Vaccine from \$13.00 to \$15.00. This will assist pharmacists in providing Albertans with timely access to all publicly funded vaccines, including influenza, pneumococcal, and dTap.

Claims submitted from October 26, 2020, to March 31, 2021, for the following PINs are eligible for a fee of \$15.00.

Retroactive claims adjustment

Alberta Blue Cross will be performing a review of claims which have been submitted for these PINs at a fee of \$13.00 between October 1, 2020, and October 26, 2020. An adjustment will be applied to provide an additional \$2.00 for each claim. This will appear within the cheque run of November 27 cut-off and electronic funds transfer deposit date of December 10, 2020. Payment reports will be accessible to the pharmacy on the Alberta Blue Cross pharmacy provider portal. The quantity on the claim transaction will reflect the number of claims adjusted.

No action is required by the pharmacy to facilitate this adjustment.
