## Retroactive claims adjustments for Assessment for the Administration of a Publicly Funded Vaccine Fee

As announced on October 26, 2020 (Benefact 908), Alberta Health has temporarily increased the fee for the Assessment for the Administration of the Publicly Funded Vaccine from \$13.00 to \$15.00. This increase is retroactive to October 1, 2020.

Claims submitted from October 26, 2020, to March 31, 2021, are eligible for a fee of \$15.00.

### Retroactive claims adjustment

Alberta Blue Cross has completed a review of claims which were submitted for the applicable PINs (see table below) at a fee of \$13.00 between October 1, 2020, and October 26, 2020. An adjustment has been applied to provide an additional \$2.00 for each paid claim. The payment details of the adjustment will appear on the Reconciliation Report for Paid Alberta Pharmacy Services (APS) Claims, along with any other APS claims from that claiming period, dated 20201128. An electronic funds transfer deposit with a date of December 10, 2020, will be made for payment of these adjustments. The drug quantity on the reconciliation report reflects the number of claims that the additional \$2.00 was applied to and the drug cost reflects the total amount paid for these adjustments. An example of how the payment will appear on the reconciliation report is provided below.
