As a reminder, effective January 1, 2021, ARTA, group 19930 "A" sections direct bill drug claims are to be submitted to Green Shield Canada. ARTA is now self-administering its Retiree Benefits Plan and Alberta School Employee Benefit Plan (ASEBP) is no longer providing this service. Additional information on claiming can be found in Benefact Number 917, December 2020.

Removal of Temporary Benefit from the Alberta Drug Benefit List (ADBL)

Due to the shortages for Mint-Spironolactone 100 mg Tablet (DIN 02488159) manufactured by Mint Pharmaceuticals Inc and Teva-Spironolactone 100 mg Tablet (DIN 00613223) manufactured by Teva Canada Limited, Aldactone 100 mg Tablet (DIN 00285455) manufactured by Pfizer Canada Inc. was added as a temporary benefit for the Alberta Drug Benefit List (ADBL).

Teva Canada Limited has advised Alberta Blue Cross that the shortage for Teva-Spironolactone 100 mg Tablet (DIN 00613223) has been resolved.

As a result, Aldactone 100 mg Tablet (DIN 00285455) will no longer be considered a temporary benefit for the ADBL **after January 15, 2021.** The following grouping was removed from the Critical Supply Product List **December 18, 2020.**

Due to the shortages for Mint-Spironolactone 25 mg Tablet (DIN 02488140) manufactured by Mint Pharmaceuticals Inc. and Teva-Spironolactone 25 mg Tablet (DIN 00613215) manufactured by Teva Canada Limited, Aldactone 25 mg Tablet (DIN 00028606) manufactured by Pfizer Canada ULC. was added as a temporary benefit for the Alberta Drug Benefit List (ADBL).

Teva Canada Limited has advised Alberta Blue Cross that the shortage for Teva-Spironolactone 25 mg Tablet (DIN 00613215) has been resolved.

As a result, Aldactone 25 mg Tablet (DIN 00028606) will no longer be considered a temporary benefit for the ADBL **after January 21, 2021.** The following grouping was removed from the Critical Supply Product List **December 18, 2020.**
