

## Reminder: ONLY Alberta Retired Teachers' Association (ARTA) "A" and "Q" sections from group 19930 move to Green Shield Canada

As a reminder, ONLY ARTA plan members from 19930 "A" and "Q" sections are impacted by the changes on January 1, 2021, resulting in ARTA benefits being managed by Green Shield Canada. See Benefact 917 December 2020 for claiming details.

All other Alberta School Employee Benefit Plan (ASEBP) covered members under group 19930 are still managed by Alberta Blue Cross. Please continue to submit direct-bill drug claims for ASEBP members under group 19930 to Alberta Blue Cross.

## Additional products added to the Alberta Public Health Activities Program (APHAP)

### INFLUENZA IMMUNIZATION PROGRAM 2020/2021

In addition to the oseltamivir products listed on Benefact 890 – September 2020, Mar-Oseltamivir 30 mg, 45 mg and 75 mg capsule, Nat-Oseltamivir 6 mg/ml oral suspension, Oseltamivir Phosphate 30 mg, 45 mg, 75 mg capsule are now eligible for the *Alberta Health Influenza Antiviral Drug Policy* as applied to *Vulnerable Persons in Congregate Living Settings (Policy)*.
