

Update to weekend premium process

As announced April 16, effective April 17, Alberta Health has applied a premium of \$10 per dose, increasing the fee from \$25 to \$35 for COVID-19 vaccine administered on Saturdays, Sundays and statutory holidays. This premium will provide pharmacies with additional resources, which can be used to support staffing required during weekends and holidays if there is demand for immunization services in your community at these times.

Alberta Blue Cross has enhanced our claims systems to accommodate these claims. **Effective May 8** (this coming weekend), all COVID-19 vaccines administered on Saturdays, Sundays and statutory holidays will require you adjust your fee to \$35 per vaccine administered on your direct bill claim.

Alberta Blue Cross has completed a review of claims that were submitted during the period of April 17 to May 2, 2021, and will be applying an adjustment. Moving forward, no further claims adjustments will occur.

Retroactive claims adjustments for the Alberta COVID-19 Pharmacy Immunization Program (ACPIP)

An adjustment has been applied to provide an additional \$10 for each ACPIP vaccination provided on either Saturday or Sunday within this period. The payment details of these adjustments will appear on the *Reconciliation Report for APS Claims* dated 20210504 along with other APS claims within this pay period. An electronic funds transfer deposit date of May 13, 2021, will be made for payment of these adjustments. The Drug Quantity on the reconciliation report reflects the number of claims that the additional \$10 was applied to and the Drug Cost reflects the total amount paid for these adjustments. An example of how these payments will appear on the reconciliation report is provided below.
